

## Group Reservations

(As approved by the Board of Directors on April 6, 2002)

All Group Reservations MUST comply with normal reservation requirements.

All Group Reservations MUST be approved and confirmed 30 days in advance.

**The R-Ranch Owners/Designated Users must be on the ranch property with their group at all times.**

### **Cabins:      Adults:**

**All Adult group reservations must list names of all parties attending. All adults must have a bed available to them.**

**All adult group reservations are limited to 20 people and**

**Must be approved by the Ranch Manager.**

**If a request is over the 20 person limit, it must be approved**

**By the Majority vote of the Board of Directors.**

### **Adult & Juvenile Groups:**

**All adult /juvenile group reservations must list names and Ages of all parties attending.**

**All parties must have a bed available to them.**

**A ratio of ONE Adult for every five Juveniles is required. This is for supervision purposes.**

**Medical waivers must be provided for each juvenile who Does not have their parent attending with them.**

**All adult/juvenile groups are limited to 20 people and**

**Must be approved by the Ranch Manager.**

**If a request is over the 20 person limit, it must be approved**

**BY the Majority vote of the Board of Directors.**

**RV:              RV use by groups must be approved by the Majority vote  
Of the Board of Directors.**

Owners/Designated Users are responsible for any damages associated with the group reservation; this includes material, parts and labor for any damage and fines



per the CC&R's. **Any Owner/Designated User with a group violating the rules may be barred from use of the ranch for group reservations for 18 months.**

This will be determined by the Majority vote of the Board of Directors. The Owner/ Designated User may still use the ranch for normal use.
